OSSC Combined In-Person & Webinar "The Quantum Industry, Education & Outreach – an Overview"

Doug Finke, Managing Editor, Quantum Computing Report, LLC Donn Silberman, Founding Director, The Optics Institute of Southern California

Abstract:

In June 2019, the OSSC invited Drs. Irani (UC Irvine) and Habif (USC) to speak on Quantum Computing from both the theoretical and experimental perspectives respectively. This was six months after the US government passed the National Quantum Initiative (NQI) Act. Donn Silberman gave a review of the NQI and introduced the speakers. Doug Finke attended that meeting and the two have kept in touch and collaborated on some quantum projects. They both serve on the Quantum Economic Development Consortium (QED-C) Workforce Technical Advisory Committee (TAC), and both will be presenting at the upcoming (Nov. 30) Quantum World Congress in Washington, D.C.

Today's presentations will provide an overview of the Quantum Industry including workforce development, education and outreach activities that will help guide the industry's progress.

About Our Speakers:

Doug Finke has been involved in the computer, semiconductor, and storage industry for over 30 years and has witnessed and helped drive the birth and growth of many new technologies during this period. He has most recently become fascinated with quantum computing and believes that many of the new technology growth patterns he has seen within the computer industry will reoccur as the quantum computing field evolves. He started the Quantum Computing Report so he could apply his wide breadth of experience to help accelerate the proliferation of quantum computing to the general marketplace.


